- To Discuss the proposed Autonomous Regulation 2025, including the curriculum structure of the B.Tech Information Technology programme
- To Discuss B.Tech IT Curriculum and Syllabi for I & II Semester under Autonomous regulation 2025.
- To Discuss Uniqueness of the Curriculum (R-2025).
- To Discuss and Approve Evaluation System.
- To Discuss about Innovative teaching /Practices Methodology adopted to handle the Emerging /Advanced Technological Concept Courses.
- To Discuss and Approve the Panel of Examiners List.
- Any other item with the permission of the Chair.

## Minutes of the Meeting

- Dr. P. Sivakumar, Chairman, Board of Studies, formally declared the meeting open and extended a warm welcome to all external, internal, and co-opted members. He expressed gratitude for their acceptance of the invitation and valued presence as members of the Board. The Chairman also highlighted the key credentials of the Institution and the Department, setting the context for the meeting. Following this, the meeting proceeded with discussions on the agenda items approved by the Chairman.
- The Chairman presented the revised Vision and Mission statements of the department, along with the Program Educational Objectives (PEOs), Program Outcomes (POs), and Program Specific Outcomes (PSOs) of the B.Tech Information Technology programme.
- The curriculum and syllabus of B.Tech Information Technology under Pondicherry University Regulations R-2023 and R-2013 were presented.
- The proposed MVIT Autonomous Regulation 2025, including the curriculum structure of the B.Tech – Information Technology programme, was presented for discussion and feedback.
- The curriculum and syllabus for the First Year (Semester I & II) of the B.Tech programme under Autonomous Regulation 2025 were presented to the Board for review and recommendations.

### The following suggestionswere discussed about Regulation:

- Dr. T. Chithralekha, University Nominee, suggested that the GPA calculation for Honor and Minor courses shall remain uniform across all sections and regulations. The existing GPA tables will be removed to maintain consistency.
- Dr. T. Chithralekha, University Nominee suggested that the End Semester Examination (ESE) marks of Honor and Minor courses shall be included in the respective semester mark statements.
- The Board member suggested that the minimum number of students required to offer Honor and Minor courses should be five (5). The earlier reference to a 40% student strength was revised.
- Dr. T. Chithralekha, University Nominee suggested that the lateral entry students opting for Honour courses must align with the academic schedule and structure of regular students, to maintain curriculum consistency and academic integrity.
- The Board member suggested that the minimum attendance requirement for eligibility to appear in the examinations shall be explicitly mentioned in the academic regulation.
- The Board member suggested that the panel of examiners may also include Professors from other Government Colleges and Universities, to ensure academic diversity and expertise.

### The following suggestions were discussed about Curriculum and syllabus:

- Dr. T. Chithralekha, University Nominee, suggested that, in the First Semester, the subject "Problem Solving Using Python" is to be introduced, while the subject "Programming in C" is to be shifted to the Second Semester.
- Dr. P. Anandhakumar, Subject Expert, suggested that laboratory courses allotted 2 hours per week is found to be insufficient, especially considering that each lab carries 2 credits. It is recommended to increase the lab duration.
- Dr. K. Suresh Joseph, Expert member, suggested that one-credit courses shall be allotted a total of 15 instructional hours, in alignment with academic norms.
- The Board member suggested that the Universal Human Values (UHV-II) course carries 2 credits and, accordingly, shall be conducted 30 lecture hours.

- Dr. N. Poonguzhali, Subject Expert, suggested that the course titled "Professional Communication for Engineers" be enhanced to include relevant topics such as computer communication skills, proposal writing, presentation skills, and technical presentation techniques, to suit the needs of computer science and engineering students.
- Dr. T. Chithralekhasuggested that Indian Knowledge System (IKS) and Environmental Sciences (EVS), being mandatory courses, may be handled by faculty members with a background in History or allied disciplines, to ensure subject relevance and effectiveness in delivery.
- The uniqueness of the R-2025 curriculum was highlighted and appreciated by the members of the board.
- A detailed discussion was held on the Innovative Teaching Methodologies and Instructional Practices being adopted to effectively deliver emerging and advanced technological concept courses.

Dr T. Chithralekha and the Board Members appreciated the efforts of the chairmanand the curriculum team for their preparation and contributions.

The meeting was concluded at 2:30 p.m. with the vote of thanks by Dr.A.Meiappane Professor, Dept of Information Technology.
