#### 1. General

In pursuance to the decision of the Apex court in Islamic Academic Education and another Vs State of Karnataka and others dated 14.08.2003, a Common Entrance Test is to be conducted by Association of Pondicherry Un-aided (Self-financing) Professional Colleges. Pondicherry Private Engineering Colleges Association has been granted permission to conduct common entrance Test in the name of "Common Entrance Test for Post Graduate Programme – 2025" (PGCET – 2025) for the purpose to admit students in the Private colleges under the Management Quota.

The application is meant for registering the candidate for Common Entrance Test (PGCET – 2025) for MBA
 Programme conducted by Pondicherry Linguistic Minority Engineering Colleges Welfare Association.

# 3. Eligibility for Admission

As a pre-requisite admission to the Management Quota to MBA Programme, candidates must have appeared in PGCET 2025. However, mere appearance in PGCET 2025 will not automatically qualify a candidate for admission to MBA Programme and the candidate should fulfill the necessary admission requirements prescribed by appropriate authorities.

#### 4. Minimum Academic Qualification

Candidates for admission to the first semester MBA Programme should have secured a minimum of 50% marks in aggregate (45% for reserved category) in any degree.
