MEMORANDUM OF UNDERSTANDING

BETWEEN

NATIONAL INSTITUTE OF EDUCATIONAL DEVELOPMENT SYSTEMS (NIEDS)

Approved by INDIAN INSTITUTE OF PUBLIC ADMINISTRATION, (IIPA) PUDUCHERRY (A Training Institute of Government of India)

AND

MANAKULA VINAYAGAR INSTITUTE OF TECHNOLOGY, PUDUCHERRY

This Agreement made and entered into on this 16.12.2021 of between MANAKULA VINAYAGAR INSTITUTE OF TECHNOLOGY, PUDUCHERRY, (hereinafter called "MVIT" and NATIONAL INSTITUTE OF EDUCATIONAL DEVELOPMENT SYSTEMS (NIEDS), approved by IIPA (hereinafter called "NIEDS" which expression shall include its successors and permitted assignees) at Puducherry.

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

- a. To promote interaction between in "MVIT" & "NIEDS" mutually beneficial areas in UPSC/IAS Training Program to the Students.
- b. To provide a formal basis for initiating UPSC- IAS Foundation course.

2. PROPOSED MODES OF COLLABORATION

"MVIT" & "NIEDS "propose to collaborate through

- a. MIT sponsoring students minimum 50(fifty) (1st,2nd,3rd and 4th year) for UPSC-IAS Training program for Final year students.
- NIEDS will conduct Teaching, Training and coaching programme for UPSC-IAS Foundation Program to all students at NIEDS/IIPA Premises.

3. FORMS OF UPSC-IAS TRAINING PROGRAMS

Four years UPSC- IAS weekend Saturday or Sunday Training Program for College including one year program for the Final year Students

4. AGREEMENTS FOR TRAINING COLLABORATION

Each Training collaboration undertaken by the parties hereunder shall be initiated by the signing of a separate training agreement between the parties, which will describe in detail:

- a. The nature, scope and schedule of the Training collaboration.
- b. The form of the Training collaboration.
- c. The estimated cost of the Training collaboration together with the amount of funding, if any, to be received from MIT students as Exams/Test Stationery Charges per Exam/Test Rs.150/- (One year 100 Exam/Test for stationery charges 15,000/-) Every year Exam Charges will be pay (100 Exams * Rs150 total Rs.15,000/-) with name of NIEDS by DD in Admission time.

NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular Training agreement, the participants may agree to limit each party's right to collaborate with others on that subject. .

TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date or may renewal next batch. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Training Agreement.

SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.

BY SIGNING BELOW, the parties, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.
